Evidence of your current employment or studies
A valid Passport with at least 6 months validity remaining and enough space to insert a visa
Original signed and sealed, Police Clearance certificate - less than 6 months old, from last place of residence
Children under the age of 18 will be required to produce a birth certificate
It helps the Caymanian authorities to assess your application if you can show evidence of or personal circumstances, which may include bank statements, evidence of assets or other sources of income.

Pay slips
