## THAI E-VISA REQUIREMENTS

### PROCESSING TIME

It is highly recommended to apply for a visa approximately one month before your intended travel date.

***The application for visa must be submitted online no more than 90 days and no later than 14 days prior to your trip.***

Consular officers reserve the right to request additional documents as deemed necessary as well as the right to reject any application without having to provide reason.

### PAYMENT PROBLEM

***In case that your payment cannot be processed through, please contact your credit card provider/Bank to resolve the issue by confirming that it is an authorized transaction and not fraudulent.***

### Visa fee

- Tourist visa (TR) single entry\$40
- Tourist visa (TR) multiple entry\$200
- Non-Immigrant visa (all types) single entry\$80
- Non-Immigrant visa (all types) multiple entry\$200

### Visa procedures for Non-Thai nationals wishing to obtain Tourist visa (Single Entry)

#### Required documents to upload in the system:

- 1) Passport Biodata Page (Must be valid within 6 months from travel date).
- 2) Photograph of the applicant 2"x2", taken within the past six months.
- 3) Declaration form (download from the E-visa website, see page 32 in the Manual here) with a signature of the applicant. (The Signer needs to be hand-signed or digitally-signed, and cannot be typed)
- 4) Proof of a round trip flight confirmation/reservation showing going from the US to Thailand and leaving from Thailand (The name of the applicant must be indicated clearly)
- 5) Copy of recent bank statement (\$700 per person and \$1,500 per family). The name of the applicant must be indicated clearly), In case of submitting a family bank statement, proof of relationship (i.e. birth certificate, marriage certificate) must be provided.

**\*\*\*Additional Documents\*\*\***

### **For non-US citizens**

- A copy of the permanent resident alien card or a copy of valid US visa
- A letter proof of employment (\*\*we don't accept pay stubs\*\*) or a letter proof of full-time student status. For self-employed, business license or business registration indicating the applicant's name.

### **For minor under 20 years old, please provide the following documents**

- Copy of a birth certificate
- Copy of marriage certificate, in case of sole custody notarized copy of the court order, must be provided.
- Copy of passports or ID of mother and father/ legal guardian
- Original letter of notarized consent for the minor to travel abroad from mother and father/ legal guardian

*\*\*\*All supporting materials that are not in English must be accompanied by certified English translations and certified by an embassy only \*\*\**

### **Visa and Procedures for Non-Thai Nationals Wishing to Obtain Tourist Visa (Multiple Entries)**

#### **Required documents to upload in the system:**

- 1) Passport Biodata Page (Must be valid within 6 months from travel date).
- 2) Photograph of the applicant 2"x2", taken within the past six months.
- 3) Declaration form (download from the E-visa website, see page 32 in the Manual here) with a signature of the applicant . (The Signer needs to be hand-signed or digitally-signed, and cannot be typed)
- 4) Proof of a round trip flight confirmation/reservation showing going from the US to Thailand and leaving from Thailand (The name of the applicant must be indicated clearly)
- 5) Copy of recent bank statement for the last 6 months with a minimum balance of \$7000 every month. The name of the applicant must be indicated clearly), In case of submitting a family bank statement, proof of relationship (i.e., birth certificate, marriage certificate) must be provided.
- 6) Proof of employment (i.e., letter from the company to confirm the position and work status), please note that the acceptance or job offer is not sufficient.

### **For non-US citizens**

### **For minor under 20 years old, please provide the following documents**

- Copy of a birth certificate

- Copy of passports or ID of mother and father/ legal guardian
- Original letter of notarized consent for the minor to travel abroad from mother and father/ legal guardian
